# 6. Supervision

<u>Practicum Supervision</u> – in weekly sessions I provide an individualized supervision for doctoral students who are implementing counseling services to children with emotional difficulties in local school districts. Supervision incorporates course information and onsite clinical placement experiences tailoring feedback to the graduate student for the purpose of learning and adapting professional practice standards. There are approximately 20 doctoral (5 PhD; 15 PsyD) students annually.

<u>Teaching Supervision</u> – in weekly sessions I provide a supervision to graduate teaching assistants who are providing instruction and supervision to second year students learning personality assessment techniques. Supervision addresses course planning, assessment of student learning and how to provide formative and summative feedback to encourage student successes. There are approximately 3 teaching assistants supervising 20 doctoral (5 PhD; 15 PsyD) students annually.
