

## **SUMMARY ANNUAL REPORT FOR DUFLEX FLEXIBLE BENEFIT PLAN**

This is a summary of the annual report of the Duflex Flexible Benefit Plan (Employer Identification Number 25-1035663, Plan Number 501) for the plan year 07/01/2021 through 06/30/2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Duquesne University Of The Holy Spirit has committed itself to pay certain medical and health FSA (medical, dental and vision) claims incurred under the terms of the plan.

### **Insurance Information**

The plan has insurance contracts with Vision Service Plan and Metropolitan Life Insurance Company to pay certain life, accidental death and dismemberment, dental, vision, long-term disability and business travel accident claims incurred under the terms of the plan. The total premiums paid for the plan year ending 06/30/2022 were \$1,681,772.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 06/30/2022, the premiums paid under such "experience-rated" contracts were \$225,941 and the total of all benefit claims paid under these experience-rated contracts during the plan year was \$193,084.
